Program Director Licensing Requirements

FOR CENTER-BASED CHILDCARE AND PRESCHOOL PROGRAMS

Federal and State laws and regulations govern the work we do. To work as a Program Director in Vermont, you must be at least 21 years of age and meet the requirements established by the Child Development Division in the Vermont Department for Children and Families. We have additional resources on our website to help you understand and document your qualifications to work as a Program Director in an early childhood setting.

If you are using a Program Director Certificate to meet the Center-based Child Care and Preschool Program requirements, you must show evidence that you have completed:

Program Director Step One

Complete a three-credit college course in **each** of the following subjects:

- 1. Child Development
- 2. Curriculum Development for EarlyChildhood Education
- Early Childhood Education and Afterschool Program Management

Program Director Step Two

Hold a Program Director Step One Certificate **and** complete a three-credit college course in **each** of the following subjects:

- Leadership Mentoring and Supervision for Early Education and Afterschool Practitioners
- 2. Human Resource Management
- 3. Legal & Financial Issues in Early Childhood and Afterschool Programs

Program Director Step Three

- 1. Completion of the Culminating Seminar (this is a 3 credit course)
- At least 1 year of direct care experience in an early childhood or afterschool program, and either 2 years of administrative experience as a Program Director, or 3 years of supervised administrative practice
- 3. Portfolio review and approval
