- ECPDS Evaluation Review

- Slide 6 Expand the breadth and depth of training and professional development related to diversity, equity, and inclusion
 - Training should include PD for trainers for best support inclusion of Vermont Guiding Principles, Diversity and Inclusion
 - PDD makes recommendations for trainings, should have racial equity and diversity included
 - Vermont AUIC BIPOC comments about organizing trainings does not support equity and inclusion necessarily
 - Johanna may share feedback with the group to help think about fully supporting Diversity / Equity efforts in organizing the trainings
 - Will ask facilitator for permission
 - PDD Role to lead the charge, anything else we can do in terms of leadership around this

- John agrees someone needs to take a leadership role for this topic
- Something to include in every agenda with the meetings
 - Search for tools that exist to help guide this inclusion
 - Vermontkidsdata.org for resources on incorporating diversity and inclusion
- Slide 7 Expanding access to online professional development opportunities
 - Becky recommends making tools for explaining why some trainings are not meeting VT criteria for online trainings
 - PPD role for defining criteria and double checking verifications
 - Sponsors are usually verifying attendance, but could be a role for PDD to create tools for field
 - Verification for online webinars/virtual trainings quality as well
- Slide 8 Expand, define, and evaluate alternative approaches to delivering professional development such as communities of practice, mentoring and coaching
 - Becky comments her experience with working with communities of practice
 - John comments about Springfield college/ regional colleges are just starting to incorporate communities of practice, NL and PPD ahead
 - Mentoring and coaching
 - Last meeting brought up to BBFSAC as a policy recommendation for funding and sustained support
 - Johanna comments on creating / lack of facilitators for creating and leading the communities of practice
 - How can PDD help identify the skills needed for a facilitator?
 - Find a facilitator on Match registry, PPD can encourage sign up
 - Multistep process for creating facilitator role in Match registry, PPD can help with this
 - Communities of practice overall
 - Counting for licensing and STARS hours make it a bit difficult for people to start
 - Guidelines require sponsor, but does not require facilitator yet
 - Benefit to connecting to peers outside of our normal organizations, might take burden off sponsors
- Slide 9 Improve professional development offerings for the field's most experienced providers
 - Creating connections with organizations we don't work closely with
 - Colleges for classes/trainings
 - Defining what 'more advanced professional development' is needed
 - What are people seeking?
 - PPD could help forward courses for the summer institute that might come out based on recommendations from the field
 - Promote opportunities for new college coursework funding available through constituency groups
 - Johanna comments what she was looking for when she was a teacher
 - All day workshops that focused on a certain topic, then find coursework related
 - Workshops help peak interest
 - How to use program assessments
 - New teaching styles
 - Looking for training that would apply for credits towards a higher college degree
 - Send a survey, or create focus groups to help answer what kind of advanced training is needed
 - Becky comments there is some information to parse from professional development summit and survey
- Slide 10 Consider ways to encourage the assignment of pre-work before and follow-up work after
 - Summer Institute as a model
 - After course work and pre meeting requirements
 - Alluded to in training recommendations
 - People have provided feedback that they don't like taking time to rehash intro level information
 - Sponsors help verify pre work in the 2+2+2 model
 - NL doesn't tell sponsors exactly what to do, but can make recommendations
 - PPD can help guide NL on recommendations

- Slide 11 Design and implement a process for ongoing annual monitoring, and undertake more formal formative evaluations every 3-4 years
 - How can we identify we are moving forward in specific areas
 - Build in elements to capture data in new CDD information system
 - What will we do next year?
 - Creating a PPD workplan, using items as a grounding place for workplan development
 - Formal evaluations are expensive
 - Financial plan for evaluation progress
- Slide 12 Collect longitudinal data to measure providers' perceptions of alignment, integration, and transformation of the ECPDS
 - NL collects info on training evaluations
 - No ways to track this? Hopeful that new CDDIS system will help with
 - Longitudinal data tracking model
 - Vermont Afterschool
 - Sponsor evaluation tracking
 - Tracking in database
 - On the individual level
 - On the training effectiveness level
 - Does it help attendees perform better?
 - Would attendees do the training again?
 - Northern Lights
 - Parallel tracking system to Vermont afterschool
 - Can PPD help guide streamlining for data tracking on trainings?
 - Provide needs for CDDIS development
 - Perceptions of alignment and integration
 - Will take some time to develop the right questions to determine growth and effectiveness
- Slide 13 Expand tags in NL and the BFIS training calendars to include domains of interest for longitudinal tracking
 - Better suited for course calendar, not necessarily Northern Lights training calendar
 - Tracking data will be better for CDDIS
- Slide 14 Revise training evaluation tools and procedures to focus on practice change
 - \circ NL will share evaluation feedback in fall and these recommendations will help guide PPD
- Slide 15 Conduct additional research to understand participants' cost related barriers to accessing professional development
 - Relating to advanced level professional development
 - Link this to identifying need of advanced PD if we do a survey for both
 - NL evaluation reflects a bit on this
- Slide 16 Conduct additional research to understand the particular professional development needs of Family Child Care Providers
 - NL evaluation relating to family childcare providers
 - Can extract that data but it doesn't automatically have the answer
 - Becky Requests help with distribution of survey link
 - John comments it's hard for providers to 'know what they don't know'
 - NL Survey will address individuals and what kind of training they are wanting
 - Asks about interest, level, and open response
 - PPD role could be to look at survey results to create best informed recommendations
 - Include someone from family child care on committee
- How to create / focus on development of a PPD workplan going forward?
 - Want one plan moving forward with prioritization and data tracking for evaluation
 - Committees work is around integration across the early childcare system rather than focusing only on quality of trainings
 - PPD can recommend language requirements for CDD grants to help with trainings
 - Inclusive for all workers in childcare, not just early childcare

 - Vermont Early Childhood Networks Use network grants to use someone to attend PPD
 - VCCPA
