- Proposed Changes to Afterschool Competencies (Tricia)
  - o Background on afterschool competencies
  - o Current competencies haven't been revised since 2007
  - o Brought to Afterschool Advisory committee for review
  - o Proposed change to NAA national competencies
  - o Three levels: Identify, Apply, Amplify

- Proposed Changes to Early Childhood Educator Competencies (Becky)
  - o Propose adopting the NAEYC Professional Standards and Competencies
  - Shared document showing alignment between current Vermont Early Childhood CKCs and NAEYC competencies
  - Two concerns raised by committee in 2021: no explicit focus on health and safety, and no explicit focus on program organization (both addressed in handout)
  - o This would not require any immediate changes to the child care licensing regulations but would be important to consider any possible future changes needed
  - o Code of Ethical Conduct was mentioned; can be incorporated into the Fundamentals revision

- STARS Revision (Johanna)
  - o Outlined the new criteria for the STARS revision and how they were developed
  - o There are several professional development components proposed at Level 2
  - o Content likely to include: DAP, VELS, implicit bias, child observation, program assessment
  - o Conversation about PD equivalence and what it might look like re: STARS
  - o Conversation about crosswalking with higher ed degrees
  - o Focusing on implicit bias doesn't fully include other components of DEI
  - o Opportunity for a reflection component paired with other ways of meeting requirements
  - STARS Revision is going into the promulgation process and should be available for public comment in early 2023 with intent to roll out new system in July 2023

- o Kate Rogers last meeting before retirement
- VTAEYC actively enrolling for TEACH, still spaces for Apprenticeship in the spring. Curtis
  Fund new scholarship for folks pursuing the CCV Child Care Certificate; this is national
  apprenticeship week
- Vermont Afterschool 200 participants at annual conference; starting SEL methods training; also working on quality standards to bring to the Governor's group
- o BBF extending their statewide committee membership survey; Preschool Development Grant has been written and submitted (\$8M/year for 3 years); Regional Council Summit coming in December; BBF SAC passed policy recommendations; next SAC meeting 11/28/2022
- NL Fundamentals spring registration opens 12/1; Revised community of practice criteria has been submitted to CDD; developing orientation for CIS professionals 12 hour training for front line staff but will also be open to admin folks and others in the EC field

- 1. Discuss and vote on proposal to recommend sunsetting Vermont Afterschool Competencies and transition to use NAA competencies in Vermont. Results of vote will be shared with CDD who will make the final decision.
- 2. Discuss and vote on proposal to recommend sunsetting Vermont Early Childhood Core Knowledge and Competencies and transition to use NAEYC Professional Standards and Competencies for Early Childhood Educators. Results of vote will be shared with CDD who will make the final decision.
