- Creating PD Recommendations: Review of Draft Document (Becky)
 - o Discuss items that came up on the Jamboard in relation to the Draft PD Document
 - A lot of programs providing PD in house and this helps to provide guidance and also for guiding statewide PD; Not requirements just guidance
 - o Asked groups for thoughts/feedback: make sure all using the same type of language, very clear, provides consistency and aligns with standards esp DEI inclusion, easy to read
 - o Training Levels: Framing is how we do it in house and tried to present similarly in the document; feedback welcome
 - Unified core knowledge page four competencies a lot more alignment for afterschool but additional pieces that are core for them that is not core for everyone.
 - o Ultimately the Competencies given to CDD to go into the CDDIS
 - O Time to transition competencies can use either set.
 - o Feedback: Early Learning standards need to be under child development as well as curriculum.
 - o Inclusion statement NAEYC to be included under DEI section.
 - o [Julia] Under #3 professional development. Include consideration for professionals working toward their EI Certification and required hours of PD...any PD opportunities for them as well....any opportunities to mark EI criteria under PD? Love love love the Connection with EE/EI-ECSE Standards-DEC core knowledge areas (great for the CDDIS system). Council for Exceptional and Under #5. Consider our early childhood programs are inclusive programs with children with special needs. How can we remember to consider these children when planning for PD, and considering Diversity, Equity, Inclusion and Belonging (and Justice) as they relate to Children.
 - o Justice and belonging language added to DEI (Adri)
 - o [Beth] I'd love the chance to review this document w/ the licensing team, specifically around #8 to see what might be missing from their perspective. :-)
 - o [Sharron] Perhaps, NAEYC's Advancing Equity Position Statement would be of use: https://www.naeyc.org/resources/position-statements/equity
 - o Include Pyramid Model under #3
 - o Training specific to Expulsion and Suspension best practices.
 - Statement of Why PD is important at the top… rationale for it why important better outcomes for children etc.
 - o Items at bottom could be added within the document instead...?
 - Under the Learn from Mental Health Clinicians... include Specialized Childcare Coordinator and other home visitors.
 - Links to references and resources as a whole are we on the right track with the document across the expanse of the audience?

- ECE competencies did go through the standards board yesterday and will go to LCAR; educator licensing is allowing folks to use previous competencies or the new ones to allow time to transition
- VELS should be included in 1. Child Development & Learning, 3. developmentally & inclusive Practices. NAEYC & DEC Position Statement on Inclusion should also be under 3. developmentally & inclusive practices. These are important references for building coursework. Thank you.
- o #3 including professionals working toward EI certification and required hours of PD
- Ways to mark that things fit under DEC competencies
- o DEI and adding B for belonging and J for Justice; I asked for guidance on clarity and something that will be longstanding
- State will be offering things related
- o #3 DAP; pyramid model practices added; looking at the best practices
- O Statement at the top about why PD is important; way to emphasize that professional preparation of our workforce is critical to positive outcomes for children
- o Including specialized child care CCC and other home visitors
- o Thinking about language for the first couple of pages; not prioritize for more than one
- Write out all the acronyms
- What about #4. as an area to include EC Mental Health Clinicians, Specialized Child Care Coordinators, or Strong Families Vermont (Sustained and responsive home visiting).
- o Could you merely delete "prioritize" for #3 would that work?
