The Northern Lights website hosts a page that links to the Vermont IHEs that offer early childhood (or related) programs and we'd like to propose a change to that page. For the past several years most institutions have emailed us the list of courses they were offering in the upcoming semester and we listed them on our website along with whatever link the IHE provided for visitors to learn more. We would like to propose moving forward that we instead host a blurb of information and related links for each institution so it requires less regular upkeep for all parties, while making the page more useful and less duplicative. Northern Lights would reach out to institutions once per year to verify the information was still accurate and institutions could contact Northern Lights requesting revisions at any time. [the link is currently not active on our website while we determine next steps]

From Kaitlyn Northey via Leslie Johnson, CCV and UVM- Praxis Core Committee update
The conversation was timely, as some IHE were in the process of discussing their policies, which
were not yet finalized on March 2nd. Anecdotal evidence suggests that the waiver opportunity has
allowed a few students to stay enrolled in their preparation program (rather than being advised into a
non-licensure track or program). Our conversation revealed that there is variation in how IHE are
interpreting the Praxis Core waiver opportunity (most notably whether 1) students are required to
attempt the Praxis Core at all, 2) provide evidence of failing a component of the Praxis Core once, or 3)
provide evidence of failing twice to be eligible at their IHE. We discussed creating a list of courses from
each institution that had been identified as satisfying Praxis Core competencies and identifying which
CCV course Essential Objectives aligned with the Core competencies. The meeting on Friday April 21st
will feature representatives from more IHE and include folks from Peer Review so we can learn from
their experiences and what might be helpful for everyone going forward. We will discuss any changes in
institution waiver policies, revelations related to implementation so far, and what other improvements
or next steps are needed.

# **Updates ECE Competencies**

The competencies were approved by the board. We will submit them to the legislative rule process later this spring or summer to make them super official with the full rule change, but folks are allowed to start using the new competencies on new applications.

As a technical reminder, anyone with an active application on the books with Ryan can still use the old competencies (although I think the new ones are more user friendly). Once the rules are finalized by the legislative rule process, new applicants will have to meet the new competencies; that includes adjustments to old portfolios if they built it up before applying.

We would like to gather information about how to advise folks who complete the 45-hour Fundamentals for Early Childhood Professionals training series and are interested in next steps at various institutions. #### Conference Focus Areas:

## Responsive Practices through an Equity Lens

We will choose workshops that aid early childhood educators in implementing developmentally appropriate practices through curriculum that meets the varied needs of infants, toddlers, and preschoolers. The workshops should also include culturally responsive practices that promote diversity, equity, inclusion, justice, and belonging.

# **Engaging Children and their Families**

We will select workshops that allow participants to partake in fun and hands-on workshops that spark joy through play and movement. We are looking for workshops that could include nature based education, loose parts, sensory activities, and PLAY! We will also select workshops that help educators cultivate their relationships with the families they serve.

## Meaningful and Intentional Interactions

We will select workshops that support teachers in how they honor the children in their care through relationship building, social and emotional learning, and trauma informed care. We want workshops to strengthen the interactions between children and the adults that care for them.

## Systems, Resources, and Supports

We will accept workshops that prepare early childhood educators to be their best selves, so they can continue creative and joyful learning. We are looking for workshops that share mental health resources, well-being supports, and systems that support their classrooms, programs, and the broader early childhood community. Content focus:

Summary of Department of Education Grant: Funds are used to support or establish campus-based child care programs primarily serving the needs of low-income students enrolled in IHEs.
