- I. Meeting introductions
- II. Creating New IPDPs for Early Childhood and Afterschool (Becky and Tricia)
  - Switched to alignment on the national level for Child Care Standards NAEYC and National Afterschool Standards.
  - Would love to see this be a more active tool for folks... make them user friendly and useful to shift folks to making these more active tool rather than just something to check off.
  - National Afterschool Deep review of skills to use as planning tool to complete the IPDP: Self-Assessment Tool
  - New draft IPDP form... NL is working on. New Self-Assessment section to dive deeper.
  - Break into groups to look at the tools anything to add, thoughts on what is in there currently.
    - Barriers and Positives
    - Wonderful tool to enhance reflective practice
    - Identify, apply and amplify folks like that.
    - Reflecting on the usefulness. This is just a tool comes down to messaging – finding trainings that directors can find a training to support an employee's IPDP goals.
    - Liked the bottom part, Goals, Strategies, Resources, Timeline...
       liked the check boxes... rating and reflecting is enough. Focus on the 2 and 3 ratings for goals.

- o Think about goals for 3-4 CKAs to develop per year, not all 10.
- Making this a living document not just a check list and connecting the IPDPs it to STARS (program plan) and annual evaluations.
- Reflection part no space for this in the unified how to you know when you met goal and how will you use in your practice.
- CIS Early Intervention Certification Renewal process similarities to their process. Lead up to the renewal process in increments so not so overwhelming.
- Program Guide for Admin to help staff.
- Need to remember that there are FCC providers who are individual and program when we are thinking about CQIs.
- Not focus on it just being an evaluation but also focus on continuous improvement personally
- Create another training for Prog Directors to train on how to assist with IPDP creation and follow thru.
- Using CKA lens across all facets of a person's role position (job description areas)
- Mindful of what we are asking Staff to do...within their very full schedule already. A lot of redundancies in paperwork. Where can we create alignment?
- And for FCC what collaborative mechanisms are available to them for completing these - akin to a community of practice in lieu of a supervisor assisting them.

## III. Early MTSS and Practice-Based Coaching Project (Amy Murphy)

- Build up a certain topic using a ladder of development (math, literacy, Social Emotional etc)
- Expand Early MTSS across ECE area Universal Pre K, Integrated Services and now to 0-5 years audience. Framework build slowly to sustainability level.
- How can we make these trainings accessible?

- Implementations sights free training and stipends. Free coaching from Pyramid Model Consortium. Looking for sights...
- Looking for Coaches as well. System coaches working with a leadership team... or Practice Based coach as well. Coaches will receive stipend as well. Per month no more than 5 hours.
- Qualifications see Amy for the application and details on Qualifications. Coaching fee – fair rate.

- Large center, usually choose a classroom to start with.
- Modes of learning Live webinars, recorded, self-paced modules...
- Looking into getting PD hours for coaching. AOE and CDD look at PD with different lens both okay but need to find an alignment.
- Implementation sights (18 Universal Pre K sights, 2 NEKCA sights under new grant 20+ more added) would get the whole gamut of training including data collection. Also working on creating internal coaching mechanisms. Embedding Equity and Trauma informed practices now.
