Introductions and icebreaker

MATCH Registry on NL Website Soft Launch (Becky and Sonja)

- MATCH registry update: the registry is in its final development stages
- Both MATCH and the instructor registry share the same database; MATCH is intended to be a place to hold individualized coaches, consultants, and advisors and give a higher level of quality assurance
- There are educational and experiential requirements for someone to join the registry, however this is not the same thing as determining if an instructor is "good" or not
- The registry has been given a "soft launch" so people in the field can join as of now. but we are still not broadcasting it widely
- For the next six months several meetings will be held to review applications to the MATCH registry and how is the application process working
- If any members of the BBF PPD meeting are interested in applying to the Match registry, they can apply after the week of 1/15/24
- Per Amy Murphy: the AOE Early Ed team is doing a train the trainer with teaching pyramid model
- There will be space in the future to add relationship-based consulting as a component for licensing PD
- Per farm-to-early ed through Shelburne Farms: how do we honor the coaches who have gotten training or are in the early childhood field? A: We are looking for them to get credit and get in the system so they can be recognized for future peer-to-peer support
- SPARCS: has its own portal but mentees could get credit through the MATCH registry in the future
- MATCH registry has been treading water for several years because most coaches didn't have availability for new mentees, but this year there are coaches with availability
- Funding for coaches: we are looking to implement systems to provide coaching without the need for private payment
- Looking for feedback over the next six months

2024 Changes to the Sponsor System (Becky and Adri)

- Upcoming changes: recognized communities of practice, rules around online trainings, changes to core knowledge areas and afterschool knowledge areas
- In 2024 all current sponsors will need to attend an updated sponsor orientation and sign a new sponsor agreement
- Sponsors will be required to renew every 3 years
- Sponsors planning Communities of Practice will need to check in with an RA prior to offering a CoP for the first time

• VTAEYC has funding for network trainings

Review PPD 2022-2024 Workplan (Becky)

- Completed:
 - Biannual PD recommendations have been created
 - Core knowledge areas have been transitioned to NAEYC standards
 - STARS system revision topics have been discussed
 - Next steps with MATCH registry implementation completed
- Paused:
 - Discussing linkages with new child care licensing requirements and any professional development required
 - Review and recommend revisions to the instructor registry
- Next Steps:
 - Integrate DEI into VT's PD
 - Establish criteria for relationship-based PD to count in the system
 - Review recommendations from 2020 evaluation of early PD system
 - Examine early childhood PD system through equity lens
 - Identify and work to address barriers to aligning PD across education, mental health, special education, etc.
 - Identify any policy recommendations that should be lifted up to BBF for consideration
- Questions: How do we track what's changed and any unintended consequences?
 - The state published its workforce report, and it would make sense to review that at the same time as the 2020 evaluation
 - Directors may be ill-equipped to manage staff burnout or other issues how to incorporate more resources for directors?
 - Can we contract someone to help with the examination of the early PD system through an equity lens?

- NL has openings in Fundamentals and a new Coping with Frustration trainings
- Intro to CLASS training on the VTAEYC website, upcoming several Saturdays in January
- VTAEYC's portal is being built, can be used to access any SPARCs resources, and will launch in February
- BBF releases annual data report on January 18th (link below)
- NE farm to school application open until January 29th
- VAI: new push on PD, just put out a big email blast that they're offering two new workshops for member-only workshops. Also have a few new open trainings coming up that aren't' program-specific; one virtual and one in person
 - Scheduled date and location for annual conference, going to be in Sugarbush resort October 24th and 25th
- CDD awarded PDG Fund farm peak grant to Bank Street Center, which will be an action research fellowship for apprenticeship with the center
- Teach national center released compendium profiles for the country link below
- First Children's Finance has a winter slate of trainings on the NL calendar in two weeks will be their one-year anniversary of operating in VT

- First Children's Finance is starting a cohort in March for new family childcares, invite-only, one for centers starting in February; business health in VT survey will be out late February
